of the International Mixed Martial Arts (MMA)
Tournament «Commonwealth Cup»

Khanty-Mansiysk, 2018

1. General provisions

- 1.1 International Mixed Martial Arts (MMA) Tournament «Commonwealth Cup» (hereinafter Event) will be hold in accordance with a corporate calendar plan of interregional, all-Russian and international physical and sports events of Russian ministry of sports for 2018, corporate calendar plan of interregional, all-Russian and international physical and sports events Mansiysk autonomous okrug Ugra for 2018, calendar plan of the all-Russian noncommercial association «Mixed Martial Art Federation of Russia» (hereinafter «MMAFR») and World Mixed Martial Art Association (hereinafter WMMAA) for 2018.
- 1. 2. The Event shall be held in accordance with Regulations of mixed martial art MMA), approved by the Order of Russian ministry of sports as of the 2nd of February 2016 № 92. 3. In accordance with paragraph 2.1 of the article 16 of the Federal law as of the 4th of December 2007 №329-Ф3 «About physical culture and sport in Russian Federation» and the order of the Russian Ministry of Sports as of the 23rd of May 2014 № 346, standards of limitations for separate categories of sportsmen and trainers on changing (changing conditions) the sports clubs or other sports organizations approved by the Presidium of the MMAFR as of the 14th of November 2012 (protocol № 4) in the «Regulations of organizing and holding of all-Russian, interregional, regional competitions including Russian MMA Championships and Russian MMA Cups, obtaining of licenses and changing» (Paragraph 6). General information about the Event is described in the Annex 1.

2. Purposes and objectives

2. The Event will be held on purpose:

- a) to level up sports mastery, to find the strongest athletes of Russian Federation and countries-members of WMMAA to take part in the Russian and international competitions;
- b) to develop Mixed Martial Art (MMA) and promote this sport in Russian Federation and countries-members of WMMAA;
- c) to promote healthy lifestyles, to encourage citizens of Russian Federation to go in for sport regularly;
- d) to improve judges' and trainers' professional skills and athletes' training level;
- e) to encourage children, teenagers and other population categories of Russian Federation to lead an active lifestyle;
- f) to educate the younger generation in the spirit of patriotism love to native country.

3. Time and the venue

3.1 The competitions will be held at the address: Khanty-Mansiysk, 21, Studencheskaya St., "Center for Development of Tennis."

3.2 The competitions will be held from the 26th till the 29th of October 2018, which includes arrival day – the 26th of October 2018, departure day – the 29th of October 2018.

4. Event organization

- 4.1. General management of the Event will be realized by the Physical culture and sport Department of Khanty-Mansiysk autonomous okrug Ugra.
- 4.2. AI «UgraMegasport» with the assistance of the noncommercial association «Federation of Mixed martial art (MMA) of Khanty-Mansiysk autonomous okrug Ugra» and chief panel of judges will responsible for holding of the competitions.
- 4.3. Chief referee of the competitions the highest-ranked referee Maksachuk Ivan Vladimirovich, Novosibirsk, mob.: 89139137042.

5. Participants and conditions of admission to the competition

5.1 The following athletes may participate in the competitions:

- Athletes who have citizenship of Russian Federation or other country-member of WMMAA

On the ground of:

- a) registration at the place of residence valid for more than 6;
- 6) study in the educational institution situated on the territory of Russia or countrymember of WMMAA,
- B) doing military service on the territory of Russia or countries-members of WMMAA;
- athletes at the age of 18 and older;
- athletes with athletic title not lower than Candidate in masters of sport in sport which include strikes and/or throws of the opponent;
- athletes received approval of credentials committee on the basis of preliminary applications sent within the established deadlines.
- 5.1 Competitions are held in 8 weight categories:
- under 56, ₹ kg: code number of the discipline 0720191811A.
- under 61,2 kg: code number of the discipline 0720081811A,
- under 65,8 kg: code number of the discipline 0720101811A,
- under 70,3 kg: code number of the discipline 0720121811A,
- under 77,1 kg: code number of the discipline 0720141811A,
- under 84 kg: code number of the discipline 0720161811A.
- under 93 kg: code number of the discipline 0720171811A,
- over 93 kg: code number of the discipline 0720181811A.
- 5.1 Participation in the competitions:
- from every team (countries-members of WMMAA) maximum 2 athletes in every weight category may be registered for participation in the competitions;
- from Russian Federation regional teams (teams from subjects of the Russian Federation) will participate in the competitions. From every region maximum 2

athletes in each weight category may be registered for participation in the competitions.

- 5.2 Registered team includes:
- athletes,
- trainer,
- team representatives.

Judge (referee) shall submit the following documents to the credentials committee: TIN, certificate of state pension insurance, passport with registration at the place of residence, Referee certificate or a copy of the order about account number and bank details (for salary transference).

7. Competitions results

- 7.1 Individual competitions will be held according the Olympic system athlete who lost a fight will be dropped out of the competitions.
 - 7.2 During drawing the following rules are applied:
- in every weight category 4 athletes who has best results at the Russian Championship 2018, WMMAA Tournaments and other rating connection with the other registered participants will be determined;
- in case if registered athletes did not participate in Russian Championship 2018 and WMMAA Tournaments, above 4 mentioned athletes will be determined according to total athlete rating which includes title in sports specified in article 1.4 of the Regulations of MMAFR, participation in professional fights (article 4.5.1 of the

Regulations of MMAFR). Total rating of an athlete will be determined by the chief panel of judges;

- defined 4 athletes are divided in the competitions standings with numbers 1 to 4. The rest of the participants will be divided in the competitions drawing lots.

7.3 Drawing at the venue will be held with the participation of credentials committee Chief and Chief Secretary of the competitions in the presence of official representatives of organizations or regional sport federations who submitted entry for the participation in the competitions.

7.4 In case if sport results between these 4 athletes will be equal, a drawing will

be held between them to divide numbers 1 to 4 between them.

7.5 Filing and hearing of protests is realized according the Regulations of MMAFR.

8. Awarding

8.1 An athlete who took the first place is awarded with a medal, first place diploma, a cup and prize money.

8.2 Athletes who took second and third places are awarded with medals,

diplomas for the second and the third places and prize money.

8.3 Trainers of athletes who took 1-3 places are awarded with diplomas of respective degree.

8.4 Prize fund is distributed in the following way:

1st place – 100 000 Rubles 2nd place – 70 000 Rubles two 3rd places – 40 000 Rubles each.

9. Safety and security arrangements of participants and spectators, participants insurance, health service support

9.1 To insure public order and safety of participants and spectators, the competitions are held at sport venue which satisfies requirements of respective normative legal acts and sport facilities should have safety permit and be included in the All-Russian Sport Objects Register, in accordance with the Federal law as of the 4th of December 2007 №329-ФЗ «About physical culture and sport in Russian Federation».

Safety of participants and spectators at sports competitions is carried out by the owner of sports facilities, in accordance with the requirements of the Safety Rules for Official Competitions approved by RF Government Regulation as of April 18, 2014 No. 353.

Sports facilities should comply with Regulations and Rules of mixed martial art MMA), approved by the Order of Russian ministry of sports as of the 2^{n} of February 2016 $N_{\rm P}$ 92. 3. The availability of sports equipment should correspond to standards. The director of the sports facility, the chief judge of the competition, the responsible person for the event should sign the Act of readiness of sports facility for holding

sports competitions for 1 day and 3 hours before the event. The signed acts should be sent before the event to the autonomous institution of KhMAO-Ugra "UgraMegaSport" by e-mail: ugrasport@mail.ru, tel./fax 8 (3467) 36-37-68.

- 9.2 Medical services for the competitions are provided in accordance with the Order of the Ministry of Health of Russia as of 01.03.2016 No. 134n "About the Procedure for organizing the provision of medical assistance to persons engaged in physical culture and sports (including preparation and conduction of physical and sports events), including the order of medical examination of persons who want to undergo sports training, engage in physical culture and sports in organizations and (or) fulfill the testing standards (tests) of the All-Russian Physical Culture and Sports Complex "Ready for work and defense."
- 9.3 Healthcare delivery is performed in accordance with the order of Ministry for Public Health and Social Development of Russian Federation as of 09.08.2010. № 613н «About healthcare delivery order during physical and sports events».
- 9.4 Compulsive doping control on the sport competitions is accordance with requirements of international standard for examining the participants defined by the international organization performed doping control and licensed by the International Olympic Committee.
- 9.5 Every participant of the competitions shall have valid medical permit of sport dispensary or onetime medical certificate which permit to participate in the competitions.
- 9.6 The Organizers shall organize working of medical personnel to control that all the participants have medical certificates which confirm state of health and permit to participate in the competitions, to examine physical condition before and during the competitions, healthcare delivery if necessary.

10. Competition entries

- 10.1 Preliminary entries are submitted according to the standard pattern (Annex 3) by the national teams of World Mixed Martial Arts Association (WMMAA) and picked teams of constituent entities of the Russian Federation; Individual entries are not permitted.
- 10.2 Preliminary entries are submitted until October 15, 2018 by e-mail: mma.hmao@yandex.ru, transportation@ugrasport.com.
- 10.3 The following documents are provided to the Credentials Committee of the competitions:
- entry in the prescribed form (Annex 2),
- document confirming the athlete's regional affiliation: civil passport, student identity card and a certificate of the scholastic institution, military registration card (hard copies), in case of athlete's transfer a copy of the minutes of the Union's Executive Committee on the transfer,
- regional licence of the athlete (hard copy),
- HIV, hepatitis B and C health certificates (hard copies) issued not earlier than 6 months before the beginning of the competitions.

- health insurance card (hard copy) and insurance contract for the given competition (hard copy),

- completed card of participant (Annex 4);

- consent to processing of the athlete's personal data (Annex 5).

In the absence of one of the listed documents the athlete is not permitted to participate in the competitions.

Representatives of the teams are personally responsible for the authenticity of the documents submitted to the Credentials Committee.

Hotel accommodation is not guaranteed for the teams that did not confirm their participation in the competitions.

11. Participants' outfit

Athletes appear stripped to the waist, wearing shorts (without locks, zippers and pockets) and an open head guard. Shin and instep guards (protection of shin and instep), groin guard, mouth guard, gloves are approved by the Russian MMA Union. 18 – 20 years old athlete must use a head guard, at the age of 21 an athlete is permitted to participate without a head guard. Knee-pads and other outfit should be flesh-colored or black, free of metal components. Before going into the ring athletes are required to wrap the gloves in red or blue adhesive tape, depending on the color of the ring corner.

12. Terms of financing

12.1. Travel costs to the venue of the competitions, accommodation and meals are paid at the expense of sending organizations as follows: meals - full-board costs 1150 Rub. a day per person, double accommodation - 1900 Rub. a day per person, single accommodation - 3000 Rub. a day per person.

Accommodation and meals of trainers and sportsmen of foreign teams are paid at the expense of AI "UgraMegaSport".
